As evidence of this appointment, a "Certificate of Designation," FAA Form 8000-5, designation number DERT-606372-CE, has been prepared for you and is enclosed.

This appointment authorizes you, within the scope of your specific authority, to assume certain responsibilities of the FAA for finding that type design data for a particular product are in compliance with applicable airworthiness requirements. Your personal authority can, with mutual agreement, be extended to other specific areas and functions where your assistance as a DER might be appropriate and desirable.

Title 14 CFR part 183 prescribes a DER appointment duration of one year and provides for annual renewals at the Administrator's discretion. To simplify our office procedures, your initial appointment is effective on this date and will be reviewed for renewal on 05/01/2021, and annually thereafter to determine that your performance has been satisfactory and that there is a continued need by the FAA for your services as a DER.

We suggest that you visit the FAA Designees and Delegation website at http://www.faa.gov/designees. This site is intended as a resource for designee information and guidance for designees to assist them in performing their designee activities in the most effective manner for the benefit of themselves, their employer, and the FAA.

FAA Orders 8100.8D, Designee Management Handbook, and 8110.37F, DER Guidance Handbook, can be obtained via the Internet for use and guidance in learning the functions and responsibilities of the FAA DER system. We ask that you give particular attention to the charts in FAA Order 8110.37F, Appendix A, which show the delegated functions and authorized areas for each engineering designee category. Your particular authority is described in paragraph three of this letter. In addition, FAA Order 8110.37F contains pertinent instructions regarding preparation and submittal of FAA Form 8110-3, Statement of Compliance with Federal Aviation Regulations, and the guidelines in Chapter 2 paragraph 8, Limitations on DER Functions. FAA Forms 8110-3 may be obtained via the FAA Internet at the website listed above

The FAA provides regulatory material and many current FAA publications such as safety data, airworthiness regulations, orders, notices, advisory circulars, and airworthiness directives online at the FAA's Regulatory and Guidance Library. This information and other related regulations

and policy may be reviewed through the appointing aircraft certification office or may be purchased from the U.S. Government Printing Office or U.S. Government bookstores.

Because it is difficult to assure that each DER has been provided with all the information they need, we encourage your close and frequent contact with our office regarding any questions you may have with respect to DER operations or procedures or when you believe that any FAA instructions to DER's should be expanded or clarified. From our standpoint, we will take every opportunity to meet with you or otherwise assist you in the performance of your authorized functions. We will always welcome your comments and suggestions for the betterment of the DER program in general or your own activities in particular.

As a DER, you are required to attend a DER recurrent seminar once every two years to maintain your knowledge of the regulations and policies, and as a condition for renewal. Seminar attendance must include a general session, and a technical session for each engineering designation that you hold. DER seminar information, including the enrollment process, is available at the Designees and Delegation website identified above.
